The **I INTERNATIONAL CONGRESS ON SECURITY AND CITIZENSHIP** aims to serve as a loudspeaker for all researchers, academics and scholars who consider that can contribute to the Congress with their multidisciplinary knowledge on security to the other participants and to all citizens through the publication of their intervention in the Congress.

This Congress will be organized by the interuniversity and interdisciplinary research team of the National R&D Project (CSO2016-77549-P), and therefore, the principal investigator, Ana Huesca, will be the Head of the Congress. Among the participants in the organization we can find The Research Team of the University of Comillas “Security and Criminal Politics”, the Educational and Social Community Risk Prevention Network (PREYSDRA) and the “Sociology of Law and Criminology” Committee of the Spanish Federation of Sociology (FES). Indeed, as a result of this last partnership, the present Congress has been designed as an interconnection meeting of the Research Committee number 14 of the FES. The organizing committee of this Congress has also been assisted by the Department of Sociology and Social Work of the Universidad Pontificia Comillas in Madrid.

For three days, from the 24th to the 26th of June 2020, a scientific program structured in Plenary Conferences, Invited Symposia, Communications and Posters will be presented in Madrid, Spain. All sessions, regardless of the presentation approach, will feature speakers of well-known national and international prestige who will present the results of their recent research.

Spanish and English will be the languages of the Congress. (There will be simultaneous translation at the Plenary Conferences).

The Congress will take place at the Faculty of Human and Social Sciences of the Universidad Pontificia Comillas of Madrid, in the Cantoblanco campus. The start date of the regular registration period is the 15th of March 2020.

STRUCTURE AND DISSEMINATION OF THE SCIENTIFIC PROGRAM OF THE CONGRESS

The scientific program of the CONGRESO INTERNACIONAL *SEGURIDAD Y CIUDADANÍA* is structured around four modalities of presentation:

- Plenary conferences by prestigious international and national speakers. The names of the speakers will be made public in the second communiqué of the Congress, on the 15th of March 2020;
- Invited symposia. The maximum number of invited symposia accepted will be 10. Proposals shall be made before the 28th of February 2020;
- Communications. The maximum number of papers accepted outside the invited symposia will be 25. Proposals shall be made before the 10th of May 2020;
- Posters. The maximum number of posters accepted will be 30. Proposals shall be made before the 30th of May 2020.

All the communications positively evaluated by the Scientific Committee of the Congress and presented in it, will be fully published as chapters of an electronic book from the Dykinson Publishing House and will be given to each of the authors when they pick up their participation certificate at the Congress. The evaluation process (double blind) will be noted on the cover of the book.

APPROACH TO THE TOPICS THAT WILL BE ADDRESSED

The name of the Congress arises from one of the main outcomes of the research “*Estudio multifactorial georreferenciado de la inseguridad en España y su correspondencia con la inseguridad subjetiva*” (Multifactorial Georeferenced Study on Insecurity in Spain and its Correspondence with Subjective Insecurity) of the National R&D Project (CSO2016-77549-P): The need for a link between the studies of security with citizenship. Thus, in the I CONGRESO INTERNACIONAL *SEGURIDAD Y CIUDADANÍA*, citizenship will be understood as an expression that groups the people that have rights in a territory who will begin to feel safe to the extent in which all their own rights can be achieved or maintained. The following topics are proposed for guidance:

- **Feelings of insecurity and quality of life**
- **Social risk factors and their prevention**
- **Cybersecurity as an emerging challenge for citizen security**
- **The role of Law Enforcement in risk reduction**
- **Judicial and penal system challenges faced on the 21st century**
- **Global risks existing in citizen uncertainties**
- **Methodologies in the study of objective and subjective insecurity**
- **Others proposed through their communications.**

CALL FOR PROPOSALS FOR INVITED SYMPOSIA (The rules for the communication and poster proposals will be annexed to the following communication)

An invited symposium will consist of a 90-minute period in which the symposium coordinator will present the symposium, manage the presentation of the contents by the symposium participants for 70 minutes and moderate the subsequent discussion for 20 minutes. Symposia that present results of current research will be especially valued.

Proposals for invited symposia can be sent to contacto_CONGRESOSEGURIDAD@comillas.edu until the **28th of February 2020** by the symposium coordinator. He will be the person who will bring together all the information received by the Organizing and Scientific Committee of the Congress and will communicate it to the members of the symposium proposed by him.

Rules for the symposium proposal presentation:

- The proposal for an invited symposium should be accompanied by an abstract of approximately 300 words on the content of the symposium.
- A title for the symposium should be included.
- The name, affiliation and an ID photo of the coordinator will appear clearly in .jpg format in order to be published on the congress website.
- The symposium will be composed of a minimum of four communications and a maximum of six not counting the contribution of the coordinator (therefore it will range between 5 and 7 communications).
- It should include information on the title and authors of each of the planned communications.
- It must include a brief CV of each of the members of the symposium, including the coordinator.

All members of the symposium will have to register for the congress by paying the corresponding fee. The symposium coordinator will NOT have to pay any fee. Each communication presented within a symposium must follow the rules established for papers (which will be sent soon) and will be signed by a maximum of two authors. In the case of two authors, the name of both authors will be included in each certificate, and both must be registered at the Congress for their paper to be published by Dykinson.
